### Exhibition

Oil, Pastel, Acrylic or Watercolor.

Works must be suitably framed, wired and ready for hanging. No glass. AIS and Saks Galleries is not responsible for loss or damaged work in shipments. Canvas size is not to exceed 24"x36", or 864 square inches excluding frame. Submission of entries and entry fee constitute agreement with all conditions set forth in this prospectus.

### Entry Information

Entry fee: \$50 for up to two artworks (up to 864 sq. in.) and one miniature works (under 40 sq. in.).  
Entry fee is to be paid on CaFÉ site.

### Slides:

Kathy Cooper, AIS Signature Member, will help any member convert slides to digital entry and enter for you. This digital entry service is available for additional fees (see DIGITAL ENTRY SERVICE FORM).

Digital images are assumed to be accurate representations of the entrant's original art works. Artwork that differs markedly from the submitted image will be disqualified.

1. Prepare your artwork images formatted to the Image Preparation specifications. Go to [www.callforentry.org/imaging\\_tips.phtml](http://www.callforentry.org/imaging_tips.phtml) for complete instructions and templates.
2. Create a profile by entering basic contact information and creating a username and password to CaFÉ™ (register at [www.callforentry.org](http://www.callforentry.org)).
3. Upload digital images of your artwork to your image portfolio.
4. Apply to **American Impressionist Society, Inc. 10th Annual Juried Exhibition at Saks Galleries**
5. Select up to 3 images from your image portfolio to apply to the AIS 9th Annual National Juried Exhibition.
6. Submit an application online.
7. Pay the \$50 entry fee online with a credit card or mail in a check (payable to AIS) to T.R. Dickinson, Tres., 856 Fifth Place, Vero Beach FL 32962.

Artists receive email notifications when their applications have been received and when they have been accepted or declined.
