**Print off your painting label and gallery information sheet from this letter and fill out all information. You will need these when you ship your work.**

**No exceptions can be made to the following dates.**

Please be sure to read these instructions carefully and mark the dates on your calendar. It is imperative that these instructions are followed completely.

**Shipping:**

**September 28- October 12:** Work MUST ARRIVE (shipped or hand delivered) between these dates.

IMPORTANT: Your work needs to be shipped to the sister gallery of Illume.

Artists must provide a prepaid return shipping label. Masterpak or Airfloat boxes (or equivalents such as U-Line) are highly recommended. Your paintings will be returned in the same box you send them in.

**October 12 is the last day for work to arrive at the gallery.**

**Please include the following items in a separate envelope in your box with your paintings (NOTE: paintings arriving without all required items below WILL NOT BE HUNG until all required items are received):**

**A prepaid return shipping label** DO NOT send cash or postage stamps. Do not use the US Postal Service for this exhibition.

The Gallery Information Sheet (see below in this letter).

Painting Identification Label (Below the Gallery Information Sheet. **Attach this to the back of your painting**)

**MasterPak and Airfloat Systems containers are recommended. Package your paintings well. We will reuse your original packing for the return. Keep it simple and neat.** Make sure your boxes are sturdy and can be reused.

**ABSOLUTELY NO PEANUTS!** If you use a packing/shipping service you must tell them not to use peanuts to avoid disqualification from the show. Any painting arriving with packing peanuts will be returned to the artist and will not be hung.

Please print your name and address prominently on the outside (preferably in the upper left corner) and inside of each box. A photo of the painting attached to the inside of the box is helpful. Mark the outside of your box with "TOP" or "OPEN HERE".

The paintings delivered must be identical to the juried images. No substitutions will be accepted. Prices may not be changed after entry.

**As stated in the prospectus, your work must be framed in a fine art gallery quality wood frame, wired and ready for hanging.**

Be sure to attach the IDENTIFICATION TAG FOR ACCEPTED WORK (below) to the back of your painting.
